Advanced Practice Provider Per Diem Job Description

Job Title: Advanced Practice Provider/ Forensic Examiner

Status/Pay Scale: Per Diem, \$80 to \$125 per hour average

Reports to: Executive Director and Medical Director

Forensic Advanced Practice Provider (APRN / PA) will participate in self-scheduling for on-call hours from their residence and respond as needed to a participating emergency department / inhouse patient in need of a forensic medical examination throughout Southwest Ohio. Average hourly rate performing forensic exam ranges \$80.00 to \$125 per hour while performing a forensic examination. The average forensic examination is 1.5-3.5 hours in length however flat rate is provided to assure provider payment.

Salary Range:

- On-call rate \$8.00 to \$10.00 per hour (varied per shift)
- Doubled on-call pay rates for holidays
- \$325.00 \$400.00 per completed forensic examination (averages \$80-\$125/hr)
- Off-shift and holiday completed exam: additional \$150 incentive pay per completed exam

Monthly on-call requirements:

- Minimum 36 hours per month that are self-scheduled (shifts are 6 hours in length)
- 12 hours of weekend call (included in the 48 hours per month)

Detailed Job Description:

A Forensic Advanced Practice Provider provides timely advanced medical forensic assessments and injury identification, documentation, forensic photography along with collection of trace biological sample collections for patients that have experienced trauma from sexual assault, human trafficking and domestic violence. The highest level of professionalism and expertise is always expected from all Forensic APPS while interacting with patients, advocates, crisis workers, physicians, APPs, nurses, law enforcement and other disciplines.

Forensic APPs will complete various types of forensic medical examinations including:

- Patient examinations post report of sexual assault, human trafficking
- Law Enforcement/Perpetrator examinations
- Strangulation examinations

Minimum Education:

- APRN: Master's degree with an Advanced Practice Nursing Focus and National Board Certification required
- PA: Master's degree required with the appropriate National Certification.

Required Certifications:

- APRN National Board Certification as a CNP, CNS, CNM, or CRNA (APRN certification to match scope of practice)
- APRN Acute Care Certification
- PA- National Commission on Certification of Physician Assistants (NCCPA)
- Basic Life Support (BLS) certification required

Required Licenses:

- Current Ohio Board of Nursing license for APRN
- Current Ohio License 50RX License to practice as a physician assistant with prescriptive authority

- Maintain collaborative/supervision agreement as required through the Ohio Medial Board/Ohio Board of Nursing. Includes yearly review/Quality Assurance and evaluations.
- Valid Ohio driver's license with clean driving record

Other Requirements:

- Must meet organizational requirements for background investigation (including criminal history) upon hire and annually.
- Current professional liability insurance (employer reimbursed)
- Must meet requirements for immunizations and negative drug screen upon hire, annually and randomly at the discretion of the employer.
- 1 year APP experience preferred however will train the right candidate with less than one year
